

# **Common Change Privacy Policy**

Common Change is fully committed to the responsible use of your personal information and the protection of your privacy. This privacy policy describes how we handle your personal information and applies to all the products and services we offer on our website (www.CommonChange.com) including any subdomains. This Privacy Policy must be read in conjunction with all other Common Change policies available on the Site (the "**Policies**") and the Terms of Service. This Privacy Policy covers Relational Tithe's, commonly referred to as "Common Change", treatment of personally identifiable information that we collect when you are on the Common Change site, on a site powered by our technology, or when you use Common Change Services.

#### **Information Collection**

#### **User Information**

Common Change collects personally identifiable information when you register as a Common Change user. When you register with Common Change, we ask for your name and e-mail address, as well as other optional information including but not limited to city, state/province, country, personal Facebook URL, and Twitter handle. Once you register with Common Change and sign in to our services, you are not anonymous to us.

#### Logs

Common Change also automatically receives and records information on our server logs from your browser. These logs may contain information such as your internet protocol (IP) address, browser version, domain name, language, date and time, the referring web site and information in your cookie files (see below for more information regarding cookie files). Through your use of certain aspects of our web site, we also may collect transactional information based on your activity on our web site. Such information may include logs of content generation, account related activities on the web site, and correspondence through the web site with us and with other users of the web site.

#### Cookies

When you browse our web site, we may send your internet browser one or more small files commonly referred to as cookies. Cookie files allow us to uniquely identify your internet browser. Common Change may set and access Common Change cookies on your computer, used to identify your participant account and to allow for the proper functioning of the Common Change website and accompanying services.

One type of cookie file we may send your internet browser is a session cookie which will automatically expire and be disabled when you exit your internet browser. We may also send your internet browser persistent cookie files which remain on your system after the end of your session and which we may access if you return to our web site at a later time. Your internet browser may allow you to disable or remove our cookie files; however, your ability to access and/or use of certain portions of our web site may be affected by taking such action.

#### **Information Sharing and Disclosure**

Common Change uses information for three general purposes:



to provide our services or information about our services to you, to customize the information/content you see, and for analysis in order to improve our services and operations,

Common Change will not sell or rent your personally identifiable information to anyone. If we use your information for a purpose different from those outlined above, we will ask for your consent prior to such use. You may choose to opt-out of such use at such time.

Common Change may send personally identifiable information about you to other companies or people when:

- We have your consent to share the information;
- We are operating a website in partnership with them and they wish to contact their participants;
- We need to share your information to provide the product or service you have requested;
- We respond to subpoenas, court orders or legal process; or
- We find that your actions on our web sites violate the <u>Terms of Service</u> or any of our usage guidelines for specific services.

We may share certain aggregated, non-personal information collected from you (such as your browser type) with third parties in order to improve our services, but such information will not be sufficient to individually identify you. We will not share your personal information to third parties for marketing purposes without your consent. If you give us your consent for such sharing, but later decide to revoke such consent, you may change your preferences by logging onto your account on our system or by contacting us at the e-mail or mailing address above.

Our web site allows you to make certain personal information about you generally available to other users of our web site. Our Terms of Use restricts how other users of our web site may use such information, but you should use caution in making personal information generally available to all users of our web site.

Our web site may allow you to e-mail a third party an invitation to use our web site. We will not use any e-mail address you provide us for such invitations except to process your request and for statistical tracking.


# **Security of Your Personal Information**

We take reasonable measures to identify and prevent unauthorized access to our systems and disclosure of your personal information. We use secure server software (SSL) encryption for certain of our services and reasonable other security measures for the remainder of our web site.

We also restrict access to your personal information to only those persons who need to know the information in order to perform the services we offer. Your personal information may be stored on computer systems maintained by an agent or service provider of Common Change, each of which will be bound by agreement to protect the confidentiality of your personal information. Our computer systems are located in the United States of America, but the computer systems of our service providers may be located in another country. We therefore may transmit your personal information outside the United States of America. In the event of dissolution or bankruptcy, all Personally Identifiable Information will be destroyed.

#### **Third Party Privacy**

This privacy policy does not apply to third parties. This privacy policy applies only to information that we collect from you. Certain portions of our web site may direct your internet browser to a third party web site or a portion of our web site controlled by a third party (typically through the use of a frame or pop-up window separate from other content on our web site). Disclosure of personal information to such third





party shall be subject to the terms of such third party's privacy policy. We are not responsible for the privacy policy or content of web sites that we do not own, even if such a site is linked on our web site.

# **Editing your Information and Preferences**

As a participant, Common Change gives you the ability to edit your Information and Preferences at any time, including whether you want Common Change to send you correspondences.

# **Changes to this Privacy Policy**

Common Change may amend this policy from time to time. If we make any substantial changes in the way we use your personal information we will notify you by posting an announcement as a rotating spotlight and/or similar method on our home page.
